RESOLUTION #2019-12-2

ROSCOMMON TOWNSHIP ELECTION COMMISSION
RESOLUTION TO PERMANENTLY DIVIDE, AMEND, CONSOLIDATE OR
REARRANGE ELECTION PRECINCTS

WHEREAS, Section 116-1954-XXXVIII, Election Precincts, of the Michigan Election Law, Public Act 116 of 1954, MCL 168.654 to 168.661, provides for township Election Commission to divide, rearrange or consolidate election precincts; and

WHEREAS, Roscommon Township has two precincts and Precinct 2 typically experiences long waiting lines during primaries and elections and Precinct 1 has fewer registered voters and much smaller lines; and

WHEREAS, Roscommon Township Election Commission has determined that rearranging Precinct 1 and Precinct 2 is appropriate to distribute the number of registered voters more evenly for the convenience of conducting more effective primaries and elections.

NOW, THEREFORE, BE IT RESOLVED that Roscommon Township Election Commission hereby directs the Township Clerk to rearrange Precinct 1 and Precinct 2, as set forth on the attached map and described as follows:

Precinct 1-the area within Roscommon Township north of the centerline of Nestel Road (with the complete southern border of Precinct 1 being in line with centerline of Nestel Road as if it ran the entire length of Roscommon Township from east to west).

Precinct 2-the area within Roscommon Township south of the centerline of Nestel Road (with the complete northern border of Precinct 2 being in line with the centerline of Nestel Road as if it ran the entire length of Roscommon Township from east to west).


The foregoing resolution offered by Election Commission Member Randall, and second offered by Election Commission Member Hose.
